AN ORDINANCE ESTABLISHING A NON-REVERTING FUND
BENEFITTING THE CITY OF CHARLESTOWN PARKS DEPARTMENT






WHEREAS, The City of Charlestown, Indiana (the "City") has a Parks Department (the "Parks Department") that sponsors activities and sells goods, all of which is beneficial to the residents of the City; and

WHEREAS, the funds and proceeds collected are most often dependent on sales, and are somewhat unpredictable because demand varies with weather and other variable factors; and

WHEREAS, the City's Common Council recognizes that funds produced through sales and other income producing aspects of the Parks Department are necessary to conduct the programs of the Parks Department, but may not always be spent in the same year the revenues are collected, and that those revenues should be captured and held in a special fund for the purpose of creating, maintaining, resupplying, and augmenting Parks Department activities.

THEREFORE, IT IS HEREBY ORDAINED by the Common Council of the City of Charlestown that effective immediately the Clerk Treasurer shall created a non-reverting account, designated the City of Charlestown Parks Department Non-reverting Fund into which may be deposited revenues, proceeds, donations, fees and other proceeds produced or collected by the City of Charlestown, Indiana Parks Department.
