

ORDINANCE NO. 2016-OR-21  
AN ORDINANCE ESTABLISHING SALARIES FOR ELECTED OFFICIALS  
OF THE CITY OF CHARLESTOWN, INDIANA FOR THE YEAR 2017

---

**WHEREAS**, The Common Council of the City of Charlestown, Indiana is required to fix the annual compensation of all city elected officials; and

**WHEREAS**, The Common Council of the City of Charlestown, Indiana finds that the salaries for the Mayor, Clerk-Treasurer, and City Council members should be established at new rates for the year 2017.

**IT IS NOW THEREFORE ORDAINED AS FOLLOWS:**

Section 1. That the salary of the Mayor of the City of Charlestown, Indiana for the year 2017 shall be paid as follows: from General Fund at the rate of Forty-Six Thousand Twenty-One Dollars and Thirty-Five Cents (\$46,021.35) per year and from the Sewer Fund at a rate of Fourteen Thousand Nine Hundred Seventy-Eight Dollars and Sixty-Five Cents (\$14,978.65) per year for a total annual compensation of Sixty-One Thousand Dollars and Zero Cents (\$61,000.00).

Section 2. That the salary of the Clerk-Treasurer of the City of Charlestown, Indiana for the year 2017 shall be paid as follows: from the General Fund at the rate of Forty-One Thousand Four Hundred Seventy-One Dollars and Five Cents (\$41,471.05) per year and from the Sewer Fund at a rate of Fifteen Thousand Five Hundred Twenty-Eight Dollars and Ninety-Five Cents (\$15,528.95) for a total annual compensation of Fifty-Seven Thousand Dollars and Zero Cents (\$57,000).






Section 3. That the salary of each of the five Common Council Members of the City of Charlestown, Indiana payable out of the General Fund for the year 2017 shall be at the rate of Six Thousand Four Hundred Sixty-Seven Dollars and Zero Cents (\$6,467.00) per year.

Section 4. Elected officials shall receive no additional salary increases in subsequent years above the average amount given to all hourly employees. This amount will not include any incentives or bonus amounts given to an hourly employee.
