I assume responsibility and liability for loss, damage, or injury of any kind sustained by any person or canine caused by my dog(s) while inside the dog park. I recognize that because of the nature of canine activities that an injury may be sustained to my dog(s), my guest(s) and me, and understand that neither persons nor dogs are covered by City of Charlestown medical or liability insurance. I understand that any dog declared potentially dangerous or vicious by the City of Charlestown Animal Control Officer, City of Charlestown Code Enforcement Officer and/or the City of Charlestown Police Department or by any other similar government entity is prohibited from using the dog park.

I now release the City of Charlestown, Indiana, the Charlestown Parks Department, its employees, volunteers, sponsors, officers or agents for any personal injuries or damages to my personal property, guest and/or dogs caused by or having resulted from my use, or that of my dog(s), of the dog park. I understand that this release applies to both present and future injuries and damages, and that it binds my heirs, executors and administrators.

I understand that I or my guest(s), or my dog(s) may be videotaped/photographed at the dog park and I agree to allow the City of Charlestown and the City of Charlestown Parks Department to use the video/photo for marketing purposes.

Clark "Doc" Werner Dog Park Rules

DOG PARK RULES

Dog park hours are dawn until dusk. Park closes at dusk.

All patrons use the dog park entirely at their own risk. The City of Charlestown is not responsible for accidents or injury.

All dogs entering the dog park MUST be registered with the City of Charlestown Parks & Recreation Department.

No animals other than dogs are permitted in the dog park.

All dogs must be accompanied by owner/handler listed when registered.

Dogs must utilize the area designed for their proper weight and size. Dogs 30 lbs. and under are permitted in the smaller dog area. Dogs heavier than 30 lbs. are permitted in the larger dog area.

All dog owners are solely responsible for their dog's actions & behavior.

Children under the age of 13 are NOT allowed in the Dog Park. Children ages 13-17 must be accompanied by an adult.

All dogs must display on their collar a City of Charlestown Dog Park Tag and Rabies Tag.

Sick or injured dogs are not allowed in the dog park.

All dogs must be restrained on leash until dog and owner are inside of the park.

All dog owners/handlers must properly remove all animal waste (scoop the poop) and dispose of in proper waste containers located in the dog park. Failure to do so will cause dog park access to be revoked immediately.

No dog food dishes, dog food, favorite toys or chews/rawhides are permitted in the dog park.

Dog owners must keep their dog(s) in sight at all times.

Unruly, rough playing, or aggressive dogs are not allowed in the park and must be leashed and removed from the park immediately.

No smoking, alcohol beverages or glass containers are allowed in any city park.

Spiked, pronged, pinch and shock collars are NOT allowed in the dog park.
